

CMC and our manufacturing partner Rock Exotica have become aware of a potential safety issue regarding the ProSwivel Pulleys listed above. We are requesting that users inspect the set screws on these pulleys before their next use. This is a precautionary measure due to the similarity between these units and the 1.1" pulleys in the [Product Recall Notice](#) that is also being issued on this date. See below for inspection instructions for these models and lot numbers.


Follow these steps for inspection:

The inspection criteria below apply to ProSwivel Pulleys manufactured from January 2018 to October 2022. The lot number corresponding to this period is 18001XXX through 22304XXX. Please note that models pre-dating 2016 may differ in their inspection procedures and visual checks, see details [here](#).

1. Verify the part number and lot number of your ProSwivel Pulley.



2. Identify the location of the set screw(s) on your ProSwivel Pulley.



3. Compare your pulley to the images in the inspection evaluation below.
